LongHorn set to build next month

A national company with a restaurant already in Salina will begin construction on another restaurant in Salina in October.

Darden Restaurants, parent company of Red Lobster, 2925 S. Ninth, filed plans with the city to build a LongHorn Steakhouse in front of Kohl's, 2580 S.

Salina planning commissioners Tuesday will review a final development plan for the 242-seat steakhouse. Construction is expected to take 18 weeks.

Dennis Lauver, president and CEO of the Salina Area Chamber of Commerce, said he is excited for Long-Horn to come to town.

"This has been in the pipeline for quite a while," Lauver said.

A representative from LongHorn could not be reached Friday night. Last month, a representative denied the company was planning to build in Salina.

The building was designed by Dallas-based Gerdes Henrichson Architecture and Development. Darden also is the parent company of Olive Garden.

The restaurant will be the first business to locate in the Kohl's tax-increment financing district and will help pay off the TIF bonds

Lauver said the other regional and national retailers and restaurants are looking to move into

Festival expands to three days, includes 80th birthday party

'Pocket' change

Lakewood students help plant a little bit of prairie in Salina

Earlier this year, Lakewood Middle School science teacher Susan Coykendall was teaching about Kansas' native prairie and its immense diversity compared with a modern lawn.

Friday — a day students weren't in school — she and several students went to Sterling House retirement home, 1200 E. Kirwin, to plant a few dozen perennials in the flower beds in the central

courtyard.

It wasn't an assignment.

"I offered the opportunity, and these are the ones who signed up," Coykendall said.

Doug Rudick, with the Smoky Hills Audubon Society — and a paraprofessional at Lakewood — said such "pocket gardens" of native prairie plants are important habitat for native birds and insects, such as butterflies.

"I'm hoping we can get lots of these established around town — at schools, nursing homes and other places," he said. "I've done something like this in my own yard — I did it to attract birds — and I've been amazed at the variety of invertebrates I'm seeing now."

The perennials, among them coneflowers, squaw weed and columbine, will come up year after year, Coykendall said. She said that because they're native to this region, they don't require much water to thrive.

Students said planting the flowers was fun — and something to

"I volunteered to do this at the Sterling House on Fairdale, too, and it was fun," eighth-grader Shaelly Cole said. "I wasn't doing anything today."

TOPEKA - A crowd of

Kansas residents gathered Friday at the Statehouse to protest Republican Gov. Sam Brownback and his administration's policies, which organizers said hurt students, elderly people and the state in general.

The hourlong rally within yards of the governor's second-floor office drew about

250 protesters who spoke against cuts in state programs, including reduced spending for public schools, the closing of some regional social services offices and the elimination of state funding for the arts.

The event was organized by a new group called Kansans United in Voice and Spirit. Protesters traveled to Topeka from Lawrence, Wichita, Salina, Winfield

Brownback? We're here. We will return and we will vote," said Crystal McComas, a clinical social worker from Lawrence who helped organize the rally. She turned toward the governor's window as she spoke.

"Are you listening, Gov.

Fellow organizer Tamara Werth, a psychologist from Lawrence, said the governor's decisions are hurting senior citizens, people with disabilities and children

by cutting spending while promising job creation. Brownback spokeswoman

Sherriene Jones-Sontag responded to the criticism by pointing out progress the administration has made since taking office in January.

"In the past eight months, Kansas has added more than 13,000 private sector jobs and turned a budget deficit into a \$100 million surplus, but there's still a lot of work to do," Jones-Sontag said.

Man on probation after shooting computer

A Salina man was placed on probation for 18 months after being convicted Thursday of a felony count of criminal possession of a firearm and a misdemeanor count of attempted possession of marijuana.

A 10-month prison sentence for the firearms charge and a six-month sentence for the marijuana charge were suspended as long as Michael N. Rodenbeek, 48, fulfills the requirements of his probation, including obtaining an

Rodenbeek was ordered to pay \$800 in Kansas Bureau of Investigation lab fees and other court costs.

According to an affidavit filed by law enforcement at the time of his arrest, the charges resulted from an

April 27, 2010, incident. According to the affidavit, Rodenbeek had been told by acquaintances that a man who had worked on his computer previously had shown them photos of Rodenbeek's girlfriend and other personal information downloaded

from Rodenbeek's computer. The affidavit said Rodenbeek told police he and his girlfriend had argued earlier in the day because she was upset and felt he hadn't

taken the issue seriously. Rodenbeek contacted Michael J. Weber that night via Facebook and asked him to come to his home to work on his computer again. He told police it had been his intent to take or destroy Weber's laptop.

When Weber got set up to run diagnostics on Rodenbeek's computer, Rodenbeek grabbed a 20-gauge shotgun that was nearby and shot the bag containing Weber's laptop, the affidavit said. Rodenbeek never pointed the gun at Weber; he told Weber to leave, and Weber left and called police, according to the affidavit.

While officers were at Rodenbeek's house investigating the incident, evidence of illegal drug use was found, according to the affidavit.

In September 2010, Weber, who initially reported that his personal laptop computer had been shot, told police he had forgotten that he had given the laptop to Rodenbeek. Weber was arrested for filing a false report, and he pleaded no contest to the charge in Salina Municipal Court.

On Sept. 29, Weber was fined \$500 and ordered to pay \$70 in court costs. Since that time, he has been assessed \$50 each of the four times he has been picked up on bench warrants for failing to pay. Court records show he owes \$615.
